1. Attendance registers: a copy of the attendance register must be enclosed in the tamper evident package for answer scripts.

3. The number of scripts packed must only be for the candidates assessed.

4. Candidates not appearing on official register must NOT be allowed to participate in the examination, Theory or Practical assessment.

5. Both Theory and Practical scripts must be marked and recorded on the official mark sheet.

6. All examination sessions should start on time as indicated on the time table. The institution/centre will be penalised for starting the examinations late or earlier than the stipulated time.

7. Invigilation Report, Registers, Scripts and Mark sheets must all be enclosed in the sealed tamper evident bag.

8. All scores must recorded on official examination Mark Sheet for candidates on register only.

The assessor should ensure that the scores recorded on marksheet are authentic, verified and consistent with the registered 9. candidates who are present for the examination only.

10. A candidate who arrives late for examinations and assessment shall at the discretion of the invigilator be admitted, given up to 30 MINUTES after the beginning of the session, but NO extra time shall be allowed.
