



Apprenticeship Training Scholarship Opportunities Outside Zambia

Background

The Technical Education, Vocational, and Entrepreneurship Training Authority (TEVETA) is a statutory body under the Ministry of Technology and Science established under the Technical Education, Vocational and Entrepreneurship Training Act of No. 13 of 1998 and the Amendment Act No. 11 of 2005 to regulate, coordinate and monitor technical education, vocational and entrepreneurship training in consultation with stakeholders. Amongst the responsibilities of TEVETA include the management of the Technical Education, Vocational and Entrepreneurship Training (TEVET) Fund.

The TEVET Fund provides for the opening of equal private and public provider access to skills development training funds on a competitive basis; a commitment to greater cost-sharing through private sector and learner contributions to the cost of training and the establishment of national quality assurance mechanisms to improve the quality of delivery and the confidence of beneficiaries in the training and skills they acquire. The TEVET Fund is expected to play an important role in assisting the Government of the Republic of Zambia (GRZ) to develop a high quality, sustainable, demand-driven, and equitable TEVET system.

Invitation to Qualified Individuals

The Government of the Republic of Zambia, through the TEVET Fund, has set aside funds from the proceeds of the Skills Development Levy towards the implementation of the **Apprenticeship Training** activities.

Therefore, the Authority is hereby inviting suitably qualified Zambian nationals to apply for Apprenticeship Training Sponsorship in the programmes below aimed at financing training priority, scarce and critical skills, in line with the 8NDP:

- 1) Bricklaying and Plastering
- 2) Carpentry and Joinery
- 3) Plumbing and Pipe Fitting/Plumbing and Sheet Metalwork
- 4) Fashion Design and Textile Technology/Design, Cutting and Tailoring
- 5) Water Supply and Sanitation/Water Operations
- 6) Cosmetology
- 7) Refrigeration

Entry Requirements

This sponsorship is available to individuals whose applications meet the criteria below:

- i. Holder of a Craft Certificate in the programmes highlighted, except for Cosmetology.
- ii. Holder of a Trade Test Level 1 only for those applying for Cosmetology.
- iii. Must have graduated from a TEVETA accredited institution in the last 10 years.
- iv. Certified copies of National Registration Card (NRC)

Submission of Applications

Applicants are required to submit copies of their qualifications and all other documentation.

Note:

1. Applicants will be subjected to an aptitude test.
2. This training will be conducted outside Zambia for a period of 2 – 3 years.
