### 1.1 Overall Purpose of the Job

To coordinate, Monitor and facilitate the conduct of TEVET examinations and Qualifications to effectively measure training standards Mechanical Engineering Programmes.

## 2 TRADE TEST OFFICER (1 POSITION)

## 2.1 Overall Purpose of the Job

To be responsible for the effective administration and execution of trade test, ensuring the assessment of technical competencies aligns with industry standards and maintain the integrity of the trade testing process, contributing to the enhancement of vocational education and workforce.

### 2.2 Key Responsibilities

- a) Ensuring precise and reliable evaluation of candidates' technical competencies.
- b) Meeting established timelines for conducting and reporting on trade tests.
- c) Implementing and monitoring measures to uphold the quality and consistency of trade testing procedures.
- d) Fostering positive relationships with candidates, instructors, and industry partners through effective communication and support.
- e) Evaluating and updating trade testing programmes to keep current with new requirements and techniques in collaboration with industry.
- f) Organizing the setting and moderation of trade testing assessments in collaboration with the respective External Examiners/Moderators.
- g) Preparing and reviewing national standards, rules, and regulations for all trades to which the trade testing should conform in collaboration with industry representatives.
- h) Conducting skills testing in accordance with the National Trade Testing Standards.
- i) Identifies and organizes the training and accreditation of trade testers.
- j) Enrolling candidates taking trade tests and assessments and processing certification of successful candidates.
- k) Registering candidates sitting for Trade Test assessments, skills award and Recognition of Prior Learning.
- I) Administering Trade Test examination, skills award, and Recognition of Prior Learning.
- m) Making activity budgets and generating invitation letters and prepare DDAC for payment of assessors.
- n) Performing any other Duties as may be assigned from time to time.
